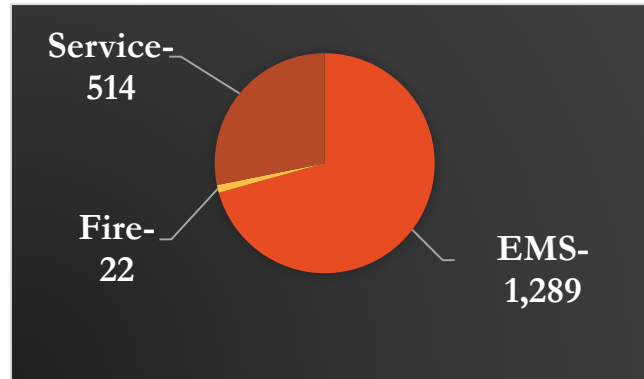




April 2024 Operations Report

Training

- Officer Development- Lt. Wessel presented an overview of the disciplinary process and employee rights. Officers participated in scenarios and held a roundtable discussion.
- Training Topics
 - Week 1- Crews toured the water treatment and wastewater facilities in Woodstock.
 - Week 2- Crews completed the MABAS Division 5 mandatory training at Huntley's burn tower. Crews worked alongside Huntley, Crystal Lake, Algonquin and other various departments in the Division. Focus was firefighter drags and carries, firefighter CPR, calling a mayday and searching for a downed firefighter. WFRD has 100% compliance in this mandatory training.
 - Week 3- Crews did a facility tour of Wells Dura-Bar.
 - Week 4- Crews participated in an auto-aid training with Algonquin and Huntley fire departments at the Huntley tower. This was a more advanced training on firefighter down scenarios. Crews, under heavy smoke, limited visibility conditions, rescue a downed firefighter and had to remove them utilizing various techniques learned from week 2.

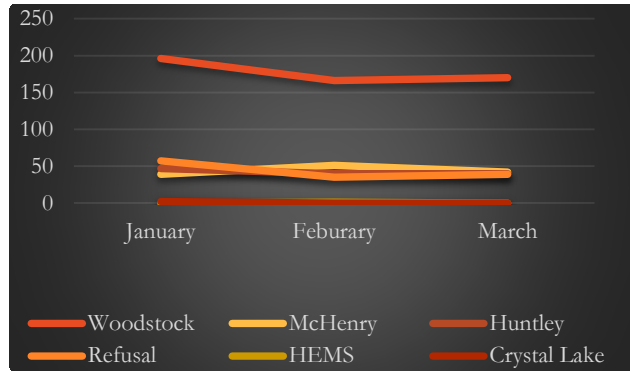
